Scholarships below cannot be combined unless noted below. Students eligible for multiple scholarships will receive the one with the most significant benefit, with the noted exceptions. Scholarship amounts cannot exceed the total cost of tuition.

Corporate Partner Scholarship

- Eligibility | Prospective students currently employed with one of Westcliff University's
 Canadian partner organizations as long as they remain enrolled and employed
- Amount | Varies depending on partnership; prospective students should consult their employer or admissions advisor for details

Refer your organization as a potential Westcliff corporate partner

Public Service Scholarship

- Eligibility | Federal, provincial, and municipal employees, law enforcement officers, public school educators, and first responders
- Amount | 20% of tuition owed each semester student is employed in an eligible field
- Application fee waiver

Diversity in Tech Scholarship

- Eligibility | Prospective indigenous students; prospective students identifying as women
- Amount | 20% of tuition owed each semester (indigenous); \$2000 annual (women)
- Indigenous women able to receive both
- Application fee waiver

Founders Scholarship

- Eligibility | Min. 3.0 undergraduate GPA (incoming students); Min. 3.0 cumulative GPA in the program after at least 12 credits completed (continuing students)
- Award | 10% of tuition owed each semester
- Can be combined with other scholarships
